Acting Mayor Beauregard Establishes a Searles Estate Future Use Advisory Committee

Acting Mayor D.J. Beauregard today announced the establishment of a Searles Estate Future Use Advisory Committee, which will consist of representatives from the administration, City Council, key municipal boards and commissions, and private and public sector subject matter experts.

“By creating this committee, I am fulfilling the promise made by the late Mayor Neil Perry during the discussions that led to the City Council’s approval of the Searles Estate purchase and adhering to the expressed wishes of the many members of the public who spoke out in favor of that purchase,” said Acting Mayor Beauregard. “Now that the purchase has been completed, the goal of this committee will be to ensure the preservation of the Searles Estate and identify its best and most productive use,” he continued.
