**Warrant for Annual Town Meeting – 1905 – File 13 No. 16**

**Essex SS: -**

To Amos G. Jones, one of the Constables of the Town of Methuen in said County

**Greeting: -**

In the name of the

Commonwealth of Massachusetts you are hereby directed to notify and warn the inhabitants of the Town of Methuen, qualified to vote in elections and Town affairs, to meet and assemble at the designated polling places of Precinct One and Two, namely: The Town Hall in voting Precinct One, and the basement of the Arlington School house in voting Precinct Two, on Monday, the sixth day of March next at six o'clock in the forenoon, to bring in to the election officers their votes for Town Clerk, Treasurer, Collector of Taxes, Selectmen, Assessors, Overseers of the Poor, Highway Surveyor, one School Committee man to serve three (3) years in place of Kimball G. Colby, one Water Commissioner to serve three (3) years in place of Alfred Newsholme, one Water Commissioner for one (1) year to fill the vacancy caused by the resignation of George A. Smith; one Trustee of Nevins Memorial to serve two (2) years in place of Lewis E. Barnes; one Tree Warden to serve one year in place of Alfred H. Wagland; Constables, Auditor, Fence Viewers and Yes or No in answer to the question, "Shall license be granted for the sale of intoxicating liquors in the Town?". All to be voted for on one ballot. The polls may be closed at four (4) o'clock p.m.. Also to meet at the Town Hall in said Town on Saturday the eleventh day of March next, at one (1) o'clock in the afternoon, then and there to act on the following articles, viz.: -

- Article 1 To choose a Moderator to preside at said Meeting.
- Article 2 To elect all Town Officers not required to be chosen by ballot.
- Article 3 To hear the annual report of the Selectmen and act thereon.
- Article 4 To raise such sums of money as may be necessary to defray Town charges for the ensuing year, and make appropriations for the same.
- Article 5 To determine the manner of collecting taxes the ensuing year and act thereon as the Town may think proper.
- Article 6 To see if the Town will authorize the Town Treasurer, with the approval of the Selectmen, to hire money in anticipation of taxes of the current municipal year, and to issue notes of the Town therefor.

Article 7 To see if the Town will vote to approve and accept the list of jurors prepared by the Selectmen for the ensuing year.

Article 8 To hear reports of Committees and act thereon.

Article 9 To determine what compensation the Town will grant the members of the Fire Department for their services the ensuing year.

Article 10 To determine the manner of appropriating the amount received from dog taxes in accordance with Chapter 102, Section 163 of the Revised Laws.

Article 11 By request of Col. William B. Greene Post. 100 G.A.R., to see if the Town will vote to appropriate two hundred (\$200) dollars for decorating the graves of our Soldiers and Sailors on Memorial Day, May 30, 1905, said money to be expended under the direction of the above Post.

Article 12 By request of the Water Commissioners, to see if the Town wishes to extend the water system, and if so to instruct the Water Commissioners to apply to the Legislature to issue bonds to the amount of twenty five thousand (\$25,000) dollars.

Article 13 By request of the Water Commissioners, to see if the Town will vote to appropriate the sum of thirty five hundred (\$3500.) dollars to be placed in the Sinking Fund.

Article 14 By request of L. C. Moore and others, to see if the Town will vote to macadamize Brook Street from Prospect Street to Jackson Street extension, and appropriate five hundred dollars for the same.

Article 15 By request of B. Scannell and others, to see if the Town will vote to macadamize Cross Street from Pelham Street to the Methuen Pumping Station, and appropriate three thousand dollars for the same.

Article 16 By request of Eben Hill and others, to see if the Town will vote to establish the grade and macadamize Milk Street from Prospect Street to Short Street and to appropriate twenty five hundred (\$2500.) dollars for the same.

Article 17 By request of Fred W. Stickney and others, to see if the Town will vote to appropriate fifteen hundred (\$1500) dollars to macadamize on Hampstead and North Streets, beginning where the work stopped in 1899.

Article 18 By request of H. F. Albezette and others, to see if the Town will vote to grade and drain Ayer Street and appropriate one thousand (\$1000.00) dollars for the same.

Article 19 By request of the Committee on the improvement of Pleasant Street, to see if the Town will vote to complete the work and make a sufficient appropriation therefor.

Article 20 By request of Lorin O. Norris and others to see if the Town will vote to construct a sewer and necessary catch basins on Central Street, from Cochrane Street to Pleasant Street, and appropriate four hundred (\$400) dollars for the same.

Article 21 By request of William Hoepfner and others, to see if the Town will vote to repair the cinder sidewalk in the Pleasant View District and appropriate one hundred (\$100) dollars for the same.

Article 22 By request of Joseph Bentley and others, to see if the Town will vote to build a sewer on Pelham Avenue, from a point near the house of Frank McDermott to the River, a distance of about five hundred feet, and appropriate five hundred dollars for the same.

Article 23 By request of A. S. Huntress and others, to see if the Town will vote to provide Policeman to patrol Jackson Street and eastward and increase the police appropriation to cover the same.

Article 24 By request of Bernhard Reuter and others, to see if the Town will vote to establish a Voting Precinct in the Currier district.

Article 25 To see if the Town will vote to furnish ten (10) grappling hooks and one flat bottom boat for use in case of drowning accidents; two sets of hooks to be kept at each of the bridges across the river on Broadway; two at the bridge across the river on Lowell Street near Graham's stables; one at the bridge across the Bartlett Brook, so called on Lowell road; one at the bridge across the Griffin Brook, and two at the lockup, all to be in the care of the Police Department, and appropriate seventy five (\$75.) dollars for the same.

Article 26 By request of Fred Miller and others, to see if the Town will vote to widen the bridge on Pleasant Valley Street, between Jackson's and the old Sargent place, and appropriate (\$50.) fifty dollars for the same.

Article 27 By request of Albert J. Richardson and others, to see if the Town will vote to have the names of all persons drawing aid from the Town inserted in the Town Report.

Article 28 By request of Zenas Christopher and others, to see if the Town will vote to compensate him for injuries and damages caused to him by the coasting accident on Park Street Dec. 29, 1904, and appropriate five hundred (\$500.) dollars for the same.

Article 29 By request of Andrew T. Jackson and others, to see if the Town will vote to appropriate one thousand (\$1000.) dollars to help compensate said Andrew T. Jackson for injuries received and loss of time by reason of a fall on the sidewalk on Broadway on the hill opposite the Town Hall, Tuesday, Dec. 27, 1904.

Article 30 By request of Henry Gaunt and others, to see if the Town will vote to construct a sewer on William Street, from Central Street to Walnut Street, and appropriate nine hundred dollars for the same.

Article 31 By request of James Robie, to see if the Town will vote to pay him fifty (\$50) dollars for rent of land for the use of stone crusher in 1903 and 1904.

Article 32 To see if the Town will vote to amend Sec. 23 of the By-Laws of the Town, by striking out therefrom the words "the chairman of the Board of Selectmen and Overseers of the Poor, Chairman of the School Committee, Chairman of the Water Commissioners, Chief of the Fire Department, and nine other legal voters, and inserting in place thereof the words, "thirteen legal voters", so that the section will read: There shall be a Financial Committee consisting of thirteen legal voters who shall hold no other Town office, and who shall be appointed by the Town Meeting for the term of one year beginning with the first day of January, and who shall serve without pay. Said Committee shall consider all Articles in the Warrant calling for an appropriation of money, and shall give at least one public hearing to parties interested before any Town Meeting, and shall report thereon at the Town Meeting. They shall have the power to fill vacancies in the Committee.

Article 33 By request of C. H. Tenney and others, to see if the Town will vote to discontinue the east end of Vine Street, from land of Edward F. Searles, easterly, to the end of said Vine Street, about one hundred and twenty three feet.

Article 34 To see if the Town will vote to appropriate three hundred (\$300.) dollars for the Methuen Improvement Society, one hundred and fifty five (\$155.) dollars of this to pay for money expended in destroying Brown Tail Moths, the remainder to be used in beautifying our streets and sidewalks.

Article 35 By request of Patrick J. Dooley and others, to see if the Town will vote to lay out and construct a highway thirty feet in width on the northeasterly to Lowell Street and to raise and appropriate a sum of money to defray the expenses of the same, or act in any way relative thereto.

Article 36 By request of the Board of Engineers, to see if the Town will vote to purchase five hundred (500) fete of hose, and appropriate three hundred (300) dollars for the same.

Article 37 By request of the Board of Engineers to see if the Town will vote to repair the Fire Alarm and replace Poles and appropriate three hundred (\$300) dollars for the same.

Article 38 By request of Joseph Buswell and others to see if the Town will vote to purchase five hundred (500) feet of liner hose, and a horse carriage, to be located near said Buswell's house, and appropriate one hundred and fifty (\$150) dollars for the same.

Article 39 By request of William Hoepfner and others to see if the Town will provide a suitable house for the Hose Cart now located on Miller Street and appropriate twenty five (\$25.00) dollars for the same.

Article 40 By request of Alfred Newsholme to see if the Town will vote to accept Ashland Avenue as laid out by the Selectmen between Almont Street and Lowell Street.

Article 41 By request of Charles W. Mann and others, to see if the Town will vote to accept a street as laid out by the Selectmen, running from Stevens Street to Cochrane Street, a distance of about four hundred and fifty feet, said street to be called Summit Avenue.

Article 42 To see if the Town will vote to sell to John Broadhead a small tract of land near to the corner of Railroad Street and Oakland Avenue and take such action thereon as the Town may think proper.

Article 43 By request of George M. Adams and others, to see if the Town will vote to change the name of Mill Street to Salem Road.

Article 44 By request of William R. Seisig to see if the Town will vote to establish and maintain a street light on Sunny Avenue, East Street and make an appropriation for the same.

Article 45 By request of Edward Crompton and others, to see if the Town will vote to establish and maintain a Gas Light on Almont Street between Oakland Avenue and Arnold Street and make an appropriation for the same.

Article 46 By request of Edward A. Bower, to see if the Town will vote to establish and maintain an arc light at the corner of Broadway and Kirk Street, and make an appropriation for the same.

Article 47 By request of Fred Hugel and others, to see if the Town will vote to establish and maintain an incandescent light near the residence of Fred Hugel on Boston Street, and appropriate eighteen (\$18.00) dollars for the same.

Article 48 By request of Joseph Thornley and others, to see if the Town will vote to move the street light from its present location, near what is known as the Crowther Cider Mill, on Lowell Street, to the corner of Closson and Lowell Streets, and make an appropriation for the same.

Article 49 By request of W. D. Clark and others, to see if the Town will vote to establish and maintain street lights at the following places:  
At the corner of East and Ashford Streets.  
At the corner of East and Channing Streets.  
At the corner of East and Globe Streets, and make an appropriation for the same.

Article 50 By request of John H. Morse and others, to see if the Town will vote to establish and maintain a street light on Lowell Street, near the house of W. P. Morse, and make an appropriation for the same.

Article 51 By request of L. C. Moore, to see if the Town will assume the maintenance of two electric lights on Brook Street, now maintained by him, and appropriate thirty six (\$36.) dollars for the same.

Article 52 By request of George L. Cross and others, to see if the Town will vote to establish and maintain two electric lights on Merrimack Street, one to be located near the house of George L. Cross and the other near the old Carleton place, and appropriate thirty six (\$36.) dollars for the same.

Article 53 By request of Edward A. Archibald and others, to see if the Town will vote to establish a street light on Cochrane Street and make an appropriation for the same.

Article 54 By request of Robert Webb and others, to see if the Town will vote to establish and maintain a street light on Webb Street near the residence of Robert Webb and make an appropriation for the same.

Article 55 By request of Robert E. Bannister and others, to see if the Town will vote to establish and maintain a street light on Pinedale Avenue, and make an appropriation for the same.

Article 56 By request of Jesse J. Prescott and others, to see if the Town will vote to purchase a new steam road roller and appropriate three thousand (\$3000.) dollars for the same.

Voted – that taxes be collected the same as last year, and that on all taxes remaining unpaid after October first, interest shall be paid from that date to the time of payment, at the rate of six per cent per annum.

Article 6 **Temporary Loans**

Voted – By a unanimous vote, that for the purpose of procuring a temporary loan, to an for the use of the Town of Methuen in anticipation of the taxes of the present municipal year, the Town Treasurer is hereby authorized and directed to borrow from time to time, with the approval of the Board of Selectmen, a sum or sums not exceeding in the aggregate sixty thousand dollars, and to execute and deliver the note or notes of the Town therefore, payable within one year after the date thereof. Any debt or debts incurred by a loan or loans to the Town under this vote, shall be paid from the said taxes of the present municipal year.

Resolved: that it is the sense of this meeting, that the river road route is preferable to the North Lowell Street route for a highway and it was adopted by a unanimous vote.

A motion that the Selectmen be instructed to withdraw the petition for a State Road by the North Lowell Street route was lost: the vote being 19 in favor to 41 opposed.

### **Wages for Opening Roads**

Voted – that the pay for opening roads be one dollar and seventy five cents per day for laborers and four dollars per day for pair of horses and driver.

Voted: that the numbers of the Finance Committee be chosen by nomination from the floor and the following named persons were appointed.

James H. Lyons, Albert J. Richardson, John Q. Hill, James O. Parker, Daniel W. Tenney, Fred Miller, Charles M. Sawyer, Edward A. Bower,

Christopher Harris, George W. Tenney, George B. Dumas, Jacob Emerson, Edwin J. Castle.

A motion to reconsider the vote whereby it was voted to fix the wages for opening roads and was made and lost – 15 to 39.

Mr. Gaunt moved to reconsider the vote, where by it was voted to pass over Article 30 of the Warrant. The motion was lost 32 voting in favor and 18 against – a two thirds vote being required.

It was then voted to adjourn without delay.

#### **Article 2      Central Grammar School Committeeman**

Mr. Hartshorne, Chairman of the School Committee offered the following  
Resolutions, which were adopted by a unanimous vote.

“Whereas, for High Schools the State’s mandate is qualified, for the Grammar and Primary grades, - within age limits, - it is absolute. The call to our children from the one is “you may”; from the other “you must”. The obligation upon the Town for care and support of each is alike in kind, if not in degree. Fortunate is Methuen; therefore, in possessing a citizen with disposition and ability to aid alike by his fortune, taste and care, not so much in rendering our burden lighter as in making conditions for education more perfect than the Town alone could ever hope to make them.

To this end the newly constructed Central Grammar School contributes in no small degree. A building less ornate than the High School, but no less well designed for the purpose; eminently practical in every detail, it bears the impress of the mastermind.

Be it therefore Resolved, that we, the citizens of Methuen, in Town meeting assembled, do gratefully accept the tender of this building by deed of gift from Mr. Edward F. Searles, and that this resolution be spread upon the records of the Town, and the School Committee be, and is hereby instructed to prepare and present to Mr. Searles an appropriately engrossed copy thereof duly attested by the Town Clerk, Selectmen, and School Committee.

Done at Methuen, this ninth day of November Nineteen Hundred and Five.

### Article 3

#### **High School Building**

Mr. Hartshorne, Chairman of School Committee offered the following Resolutions, which were unanimously adopted. “Whereas, in the colonial days of sixteen hundred and thirty-six, by a “vote of four hundred pounds to found a college, Massachusetts was the first commonwealth in history to appropriate public funds for educational purposes, which grant was two years later augmented by half the fortune of John Harvard, thus founding Harvard University, and Whereas, during the more than two and a half intervening centuries not only has that institution flourished and grown great, but public education itself has ever been regarded as the bulwark of the state, and high minded, public spirited, well endowed citizens have, ever and anon, come forward with their wealth to develop and expand the opportunity demanded by the state, of each community for the education of its youth,

So now our Town of Methuen has in these latter days been greatly honored by a wealthy son, not only by the gift of a magnificent home for our High School, but by the love and care which the further possibilities of this building imply. If a think of beauty be a joy forever, then great

should be our joy and his, for not only is this building beautiful but it is built to endure the ravages of time. Now therefore be it Resolved by the Citizens of Methuen in Town Meeting assembled, that to Edward F. Searles, the donor, there is now, and shall ever be due a debt of appreciation and gratitude not to be expressed in words, and that we commend to our children, and our children's children, in the use of such riches as God and their own efforts may endow them with, a like spirit of disposal.

Be it further provided that this resolution be spread upon the records of the Town, and that the School Committee be and is hereby instructed to prepare and present to Mr. Searles an appropriately engrossed copy thereof, duly attested by the Town Clerk, Selectmen and School Committee.

Done at Methuen this ninth day of November nineteen hundred and five.

Article 4 **School House Lot**

Voted: - by unanimous vote, that the Selectmen be authorized to transfer by deed to Mr. Edward F. Searles the real estate belonging to the Town adjacent to the new Central Grammar School Building, and that the Selectmen be authorized to sign said deed in behalf of the Town.

No further business appearing, it was voted to dissolve the meeting.

## Article 8

### Reports of Committees

The Committee to who was referred the petition for a voting precinct in the east part of the Town presented the following report: -

Your Committee were unable to find any suitable place already erected and centrally located that could be adapted for the purpose at issue. The cost of erecting a portable or permanent booth, sufficiently large for the accommodation of the legal voters and election officers would cost, approximately \$150.00.

The number of voters who would be directly convened would not exceed fifty or seventy five, while the total number convened would not exceed one hundred and twenty five. The cost to the Town outside of the erection and care of the voting booth would be about one hundred dollars per year. The means of transportation to the present voting precinct are convenient, and necessitates an annual expenditure not exceeding forty cents per capita per year, and a portion of this is generally contributed by Town committees and candidates for office.

Until the Town has some building, which could be used for the purpose at issue, or the number of legal voters to be convened has increased, your committee would recommend no change.

J. Dooley and others and that they do not favor said highway unless Lawrence bears their proportion of expense.

Article 4      **Macadam**

Under Article 4, it was voted to appropriate four thousand dollars for Macadam, the same to be taken from the street railway and excise tax.
