## **Warrant for Annual Town Meeting 1907 – File 13 No. 22**

**Essex SS: -**

To Amos G. Jones, one of the Constables of the Town of Methuen in said County: -

**Greeting: -**

In the name of the Commonwealth of Massachusetts you are hereby directed to notify and warn the inhabitants of the Town of Methuen qualified to vote in elections and Town affairs, to meet and assemble at the designated polling places of Precinct One and Two, namely: - the Town Hall in voting Precinct One, and the basement of the Arlington School in voting Precinct Two on Monday the fourth day of March next at five forty five o'clock in the forenoon, to bring in to the election officers their votes for Town Clerk, Treasurer, Collector of Taxes, Selectmen, Assessors, Overseers of the Poor, Highway Surveyor, One School Committeeman to serve three (3) years in place of William H. Craven, One Trustee of Nevins Memorial to serve two (2) years in place of Lewis E. Barnes, One Tree Warden to serve one (1) year in place of Alfred H. Wagland, Constables, Auditor, Fence Viewers, and Yes or No in answer to the question., "Shall license be granted for the sale of intoxicating liquors in the Town?" All to be voted for one ballot.

The polls may be closed at four (4) o'clock p.m.

Also to meet at the Town Hall in said Town on Saturday the ninth day of March next, at one (1) o'clock in the afternoon, then and there to act upon the following articles, viz.: -

- Article 1 To choose a Moderator to preside at such meeting.
- Article 2 To elect all Town Officers not required to be chosen by ballot.
- Article 3 To hear the annual report of the Selectmen and act thereon.
- Article 4 To raise such sums of money as may be necessary to defray Town charges for the ensuing year and make appropriations for the same.
- Article 5 To determine the manner of collecting taxes the ensuing year and act thereon as the Town may think proper.
- Article 6 To see if the Town will vote to authorize the Town Treasurer with the approval of the Selectmen, to borrow, during the municipal year beginning Jan. 1, 1907, in anticipation of the collection of taxes of said year, such sums of money as may be necessary for the current expenses of the Town, but not exceeding the total tax levy for said year, giving the notes of the Town therefore, payable within one year from the dates thereof. All debts

incurred under authority of this vote shall be paid from the taxes of the present municipal year.

Article 7 To see if the Town will vote to approve and accept the list of jurors prepared by the Selectmen for the ensuing year.

Article 8 To hear reports of committees and act thereon.

Article 9 To determine what compensation the Town will grant the members of the Fire Department for their services the ensuing year.

Article 10 To determine the manner of appropriating the amount received from dog taxes in accordance with Chapter 102 Section 163 of the Revised Laws.

Article 11 By request of Col. William B. Greene Post, No. 100 G.A.R., to see if the Town will vote to appropriate two hundred (\$200.) dollars for decorating the graves of our soldiers and sailors on Memorial Day, May 30, 1907. Said money to be expended under the direction of the above Post.

Article 12 By request of the Samuel Adams Chapter, Daughters of the American Revolution, to see if the Town will vote to request that all Bells in Town be run for fifteen minutes at sunrise, noon and sunset on July 4<sup>th</sup> 1907.

Article 13 By request of Samuel Adams Chapter, Daughters of the American Revolution, to see if the Town will vote to repair the Town Hall and put it in suitable condition for rental.

Article 14 By request of Eben Hill and others to see if the Town will vote to continue the macadamizing of Milk Street to Pleasant Valley Street, and appropriate three thousand (\$3000) dollars for the same.

Article 15 By request of the Water Commissioners to see if the Town will vote to appropriate three thousand (\$3000.00) dollars to be placed in the Sinking Fund.

Article 16 By request of Mrs. Edward F. Johnson and others to see if the Town will vote to construct a sewer on Ditson Place to the line of Mrs. Edward F. Johnson and appropriate two hundred and fifty (\$250.00) dollars for the same.

Article 17 By request of James H. Lyons and others, to see if the Town will vote to lay a sewer on Elsmere Ave. and appropriate six hundred (\$600.00) dollars for the same.

Article 18 By request of the Board of Selectmen to see if the Town will vote to appropriate forty five (\$45.00) dollars to pay for placing a Memorial

Tablet in the monument to be erected at Provincetown, Cape Cod, as a memorial of the first landing of the Pilgrims.

Article 19 By request of C. D. and S. L. Holman to see if the Town will vote to build a sewer in Hawthorne Ave., a distance of four hundred and forty feet, and appropriate four hundred and forty (\$440.) dollars for the same.

Article 20 By request of Moses G. Smith and others, to see if the Town will vote to widen Lowell Street from a point near the corner of Hampshire Street to Pine Avenue and appropriate the sum of thirty five hundred (\$3500.00) dollars for the same.

Article 21 By request of William H. Craven and others to see if the Town will vote to purchase a strip of land on the westerly side of Railroad Street between Arnold Street and Oakland Avenue, said land to be of sufficient width to build a respectable sidewalk and appropriate a sum of money to defray the expense of the same.

Article 22 By request of Edwin J. Castle and others, to see if the Town will vote to instruct the Selectmen to take by the right of eminent domain or otherwise, providing the Town has no legal rights there, land in front of the building owned by Henry C. Magoon at the corner of Lowell and Railroad Streets, as may be needed for highway purposes.

Article 23 By request of John O'Malley and others, to see if the Town will vote to give the men employed by the Street Commissioner two (2) dollars per day for nine hours works.

Article 24 By request of G. A Lewis, Manzer Prescott and John Cox, to see if the Town will vote to pay them twenty five (25) cents more per day for their services as drivers of the Town teams.

Article 25 By request of the Trustees of the estate of James Bicknell, to see if the Town will construct a suitable culvert beginning at a point near the junction of East and Jackson Streets at a point where Bloody Brook, so called, leaves said Jackson Street and enters the land of the late James Bicknell; to run from said point of entrance on Bicknell's land to the Lawrence line; the purpose of said culvert to be to change the course of said Brook so that it may run by the line of said Jackson Street to the Lawrence line and appropriate a sufficient sum of money for constructing the same.

Article 26 By request of Henry Griffin to see if the Town will vote to bear the expense of laying a retaining wall and grading the same, on the west side of Griffin Bridge on Lowell Street, and appropriate two hundred (\$200.00) dollars for the same.

Article 27 By request of J. G. McAllister and others to see if the Town will vote to lay thirteen hundred and sixty 1360 feet of six inch water pipe and appropriate thirteen hundred (1300.00) dollars for the same.

Article 28 By request of John Q. Hill to see if the Town will vote to lay water pipe from Charles E. Richardson's on the Lowell road to the icehouses of John Q. Hill, a distance of twelve hundred feet and appropriate fifteen hundred dollars for the same.

Article 29 By request of the Water Commissioners to see if the Town will vote to install a new pump at the pumping station, and make an appropriation for the same.

Article 30 By request of Joseph Stringer and others, to see if the Town will vote to accept Booth road as a Town way as laid out by the Selectmen, a distance of about seven hundred feet.

Article 31 By request of George B. Dumas and others, to see if the Town will vote to direct the Overseers of the Poor to employ a resident physician and surgeon for the ensuing year, at the fixed sum named in the lowest competitive sealed bid (provided more than one is made) to treat all patients (except small pox patients) who are receiving aid from the Town and require medical or surgical treatment and to furnish all medicine necessary for such treatment.

Article 32 By request of William H. Jewell and others, to see if the Town will vote to extend the water pipes from the present terminus on Howe Street to the residence of George Taylor on said street, and appropriate forty five hundred (\$45.00.00) dollars for the same.

Article 33 By request of Isaac C. Brown and others, to see if the Town will vote to place a public drinking fountain at the corner of Pleasant, Jackson and Prospect Streets, and make an appropriation for the same.

Article 34 By request of Aug. Seiferth and others to see if the Town will vote to appoint a committee to investigate the feasibility, expense, etc. of constructing a sewer to take care of the sewerage from district known as Pleasant View and report findings at next Town Meeting.

Article 35 By request of William M. Rogers and George W. Tenney to see if the Town will vote to have the annual report for 1907 of the Selectmen, with the reports of the Town Clerk, Treasurer, Collector of Taxes, Highway Surveyor, Engineers of Fire Department, Tree Warden, Water Commissioners and School Committee printed early enough to be ready for distribution on or before the twelfth day of February next.

Article 36 By request of Willard R. Whitney and others to see if the Town will vote to accept Sections 21-22-23-24 and 25 of Chapter 78 of the Revised Laws, and if accepted to elect a Board of Cemetery Commissioners.

Article 37 By request of Thomas Mack and others, to see if the Town will vote to appoint a Plumbing and Sanitary Inspector, who shall take a civic service examination as a fit person for the same, and be a resident and voter of the Town of Methuen.

Article 38 By request of Thomas Hubbard to see if the Town will vote to have all police duty in the Town of Methuen done by citizens of the Town except in mills and shops.

Article 39 by request of Henry Griffin and others to see if the Town will vote to extend the water pipes to the Bartlett school and maintain the same, and appropriate two thousand dollars.

Article 40 By request of Henry Read and others to see if the Town will vote to lay pipes from Ayer Street to Riverdale Street to complete the circle there by avoiding dead ends.

Article 41 By request of Fred E. Joy and others, to see if the Town will vote to accept the extension of Edgewood Avenue, as laid out by the Selectmen a distance of about three hundred feet.

Article 42 By request of Edward Byrne and others, to see if the Town will vote to build a sidewalk on Ayer Street and appropriate two hundred (\$200) dollars for the same.

Article 43 By request of Almina Stahrer and others, to see if the Town will vote to accept Alvin Street as laid out by the Selectmen; said Alvin Street, now a private way forty feet wide, running southeasterly about six hundred feet.

Article 44 By request of Arthur L. Scollay and others, to see if the Town will vote to accept the extension of Cypress Avenue as a Town way, about one hundred feet from its present terminus as laid out by the selectmen.

Article 45 By request of William R. Seisig and others, to see if the Town will vote to place a street light at the corner of Sunny Avenue and East Street, and make an appropriation for the same.

Article 46 By request of Robert Rasch and others, to see if the Town will vote to place a street light on Boylston Street, east of Kendall Street, and make an appropriation for the same.

Article 47 By request of Isaac C. Brown and others, to see if the Town will vote to place a street light at the corner of Pleasant Valley and Howe Street, also a street light between the houses of Isaac C. Brown and Thomas Keron, and make an appropriation for the same.

Article 48 By request of Rudolph Jahn and others, to see if the Town will vote to place a street light on Merrimack Street near Combination Street, so called, and appropriate a sum of money for the same.

Article 49 By request of Herbert Marshall and others, to see if the Town will vote to place a street light on Maplewood Avenue, about three hundred feet distance from Lowell Street and make an appropriation for the same.

Article 50 By request of Charles H. Foss and others, to see if the Town will vote to change the street light from the south corner of Arnold and Railroad Streets, to the north corner of Arnold and Railroad Streets.

Article 51 By request of S. C. Kelley and others, to see if the Town will vote to place a street light at the corner of Webb St. and Edgewood Ave. and appropriate twenty three dollars for the same.

Article 52 By request of E. A. Archibald to see if the Town will vote to maintain a street light already in, at the corner of Cochrane and Exit Street, and make an appropriation for the same.

Article 53 By request of Percy A. Read and others to see if the Town will vote to place three street lights on Ayer Street, three lights on Riverdale Street and four lights on Merrimack Street, and make an appropriation for the same.

Article 54 By request of James R. Bailey and others, to see if the Town will vote to widen Brook Street to a width of 40 feet thereon, or vote to macadamize said street at its present width and appropriate five hundred dollars therefor.

Article 55 By request of Arthur Redford and others, to see if the Town will vote to place a fire alarm box on the corner of Myrtle Street and Tyler Street, and appropriate one hundred (\$100.) dollars for the same.

## Article 6

Voted: - by a unanimous vote, that the Treasurer be and hereby is authorized with the approval of the Selectmen, to borrow during the municipal year beginning Jan. 1<sup>st</sup> 1907 in anticipation of the collection of taxes the sum of seventy five thousand dollars (such sums of money as may be necessary for the current expenses of the Town but not exceeding the total tax levy for said year) giving the notes of the Town therefore, payable within one year after the date thereof. All debts incurred under the authority of this vote shall be paid from the taxes of the present municipal year.

Article 8      **Reports of Committees**

The report and recommendations of the Finance Committee was read by Edward A. Bower and report was accepted. Mr. Castle reported verbally for Committee on Article 49 of the Warrant of last year, and recommended widening the street from Hampshire Street westward. Report was accepted but no further action taken.

Mr. George W. Tenney reported for the Committee to who was referred Article 37 of the Warrant for last year and the report was accepted.

Article 9      **Fire Department**

Voted that the pay of members of the Fire Department be the same as last year.

Article 10      **Dog Licenses**

Voted that the money received from Dog Licenses be appropriated to the used of the Schools.

Article 11      **Memorial Day - \$200.00**

Voted to appropriate two hundred dollars for decorating the graves of our soldiers and sailors on Memorial Day May 30, 1907. Said money to be expended under the direction of Col. William B. Greene Post 100 G.A.R.

Article 12      **Bell ringing July 4<sup>th</sup>**

Voted that the Town request that all bells in Town be rung for fifteen minutes at sunrise, noon and sunset on July 4<sup>th</sup> 1907.

Article 13      **Town Hall - \$400.00**

Voted to repair the Town Hall and that four hundred dollars be appropriated for that purpose.  
Voted that the contract for the inside work be let to the lowest responsible bidder.

Article 14 **Milk St. - \$2000.00**

Voted to continue to macadamizing of Milk Street to Pleasant Valley Street and appropriate two thousand dollars for that purpose.

Article 15 **Sinking Fund - \$3000.00**

Voted to appropriate three thousand dollars to be placed in the Water Sinking Fund.

Article 16 **Ditson Place Sewer**

Voted to construct a sewer on Ditson Place to the line of Mrs. Edward F. Johnson and appropriate two hundred and fifty dollars for that purpose.

Article 17 **Sewer \$600.00 – Elsmere Avenue**

Voted to lay a sewer on Elsmere Avenue and appropriate six hundred dollars for that purpose.

Voted, - by a unanimous vote, that the Treasurer be and hereby is authorized with the approval of the Selectmen to borrow during the municipal year beginning Jan. 1<sup>st</sup> 1908 in anticipation of the collection of taxes, the sum of Eighty Five Thousand Dollars (such sums of money as may be necessary for the current expenses of the Town, but not exceeding the total tax levy for said year) giving the notes of the Town therefor, payable within one year after the date thereof. All debts incurred under the authority of this vote shall be paid from the taxes of the present municipal year.

Voted that when this meeting adjourns, it adjourn to meet at this place, one week from today at one o'clock p.m.

### **Record of Special Town Meeting July 6, 1908**

**A meeting of the Inhabitants of the Town of Methuen qualified to vote in Elections and in Town affairs was held at the Town Hall in said Town on Monday July sixty A.D. 1908 at seven thirty o'clock on the evening pursuant to Warrant No. 2 File 14.** The meeting was called to order at the time named in the warrant by Joseph S. Howe, Town Clerk who read the Warrant under which the meeting was held.

Article 1     **Moderator**

Granville E. Foss was chosen Moderator and was sworn. Hon. J. O. Parker reported for the Finance Committee on the several articles in the Warrant.

Article 2     **Committee on Lighting Streets**

Mr. Edgar Gilbert reported verbally for the Committee on Street Lighting, and said they were not yet ready to make a final report, but that they had investigated the subject and hoped to be able to recommend definite action very soon.

The report was accepted as progressive.

Article 3     **Hose, etc. - \$500.<sup>00</sup>**

Voted: - That eight hundred feet of hose be purchased and that Five Hundred Dollars be appropriated for that purpose.

Voted: - That the Fire Engineers be instructed to procure the hose as soon as possible.

#### Article 4

##### **Sewer Loan**

Voted: - by a unanimous vote, that for the purpose of paying for the construction of sewers which were voted to be built at the Annual Town Meeting in March 1908, the Town Treasurer is hereby authorized and directed to borrow with the approval of the Board of Selectmen the sum of Seven Thousand five hundred Dollars, and to execute and deliver the notes of the Town therefore, payable as follows: - Four Thousand Dollars in seven years from the date of issue, and Thirty five Hundred Dollars in eight years from the date of issue, with interest thereon at the rate of four per cent per annum payable semi-annually.

The funds necessary to pay off said load at maturity to be raised annually by taxation in proper amounts, so that a fund will be raised and set apart yearly sufficient with its accumulations to extinguish the debt at maturity.

#### Article 5

##### **School House Loan**

Voted, by a unanimous vote, that for the purpose of paying for the enlargement of the West School House, the Barker School House and the Marsh School House, the Town Treasurer is hereby authorized and directed to borrow with the approval of the Board of Selectmen, the sum of nine thousand dollars, and to execute and deliver the notes of the Town therefor, payable as follows: - Five Thousand Dollars in nine years from the date of issue and Four Thousand Dollars in Ten years from the date of issue, with interest thereon at the rate of four per cent per annum payable semi annually by taxation in proper amounts, so that a fund will be raised and set apart yearly sufficient with its accumulations to extinguish the debt at maturity.

#### Article 6

##### **Water Works Extension**

Voted, - by a unanimous vote, - that the Town make further improvements and extensions in its water supply system in addition to what has already been done, to the extent of a total cost of Fifteen Thousand Dollars in all, and that the sum of Fifteen Thousand Dollars be appropriated therefor.

#### Article 7

##### **Water Bonds**

Voted: - by unanimous vote, - that the Town borrow the sum of Fifteen Thousand Dollars for the purpose of extending and improving its system of water supply and paying for the same, and that for that purpose the Town issue fifteen (15) bonds of One Thousand dollars (\$1000.00) each,

to be signed by the Water Commissioners and countersigned by the treasurer bearing interest at the rate of four per cent (4%) per annum payable semi-annually. Said bonds to be payable one each year beginning with the first until all are paid, payment to be provided for in such annual payments as will extinguish the debt as it matures, and pay the interest thereon.

Article 8

### **New Pump**

Voted: - by a unanimous vote; that for the purpose of paying for the new pump and equipments at the pumping station, the Town Treasurer is hereby authorized and directed to borrow with the approval of the Board of Selectmen, the sum of Seven Thousand Dollars and to execute and deliver the notes of the Town therefor, payable as follows: - Four Thousand Dollars in five years from the date of issue and Three Thousand Dollars in six years from the date of issue with interest thereon at the rate of four per cent per annum payable semi-annually. The funds necessary to pay off said loan at maturity to be raised annually by taxation in proper amounts, so that a fund will be raised and set apart yearly sufficient with its accumulations to extinguish the debt at maturity.

Article 9

### **Peter F. Graham Horse, etc.**

A motion was made to pay Peter F. Graham Two Hundred Dollars and after considerable discussion a vote was taken and was lost – 38 Yeas to 59 Noes.

Article 10

### **Moderator**

Voted to elect at the next annual election of Town Officers, a Moderator to serve for the term of one year, in accordance with Sec. 359, Chap. 560 of the Acts of 1907.

Article 11

### **Water Pipe Pelham Street**

After considerable discussion on Article 11, a vote was taken and a vote to extend the pipe appeared to be carried; The vote being doubted the vote was taken by a show of hands, and it was voted (59 to 26) to extend the water pipes from Marsh School up Pelham Street fifteen hundred feet.

A motion to appropriate fifteen hundred dollars to pay for the same was lost, 43 to 63.

Article 12

### **Water Pipe Howe Street**

A motion to pass over Article 12 was made, and lost, 26 – 44. It was then voted to extend the water main down the Howe Road to Pond Street and appropriate one thousand dollars for that purpose, carried by a hand vote – 52 to 26.

**Article 13      Ventilator**

A motion to pass over Article 13 of the Warrant was lost. It was then voted to place a ventilator on the Town Hall building and appropriate seventy five dollars for that purpose to be taken from the appropriation for Contingencies.

**Article 14      Fire Alarm**

Voted: - To install a fire alarm box at the lower end of Pine Street and appropriate one hundred and fifty dollars for that purpose.

**Article 15      Street Drain**

Voted, to pass over Article 15 of the Warrant.

**Article 16      Sewerage Reconsideration**

Voted to pass over Article 16 of the Warrant.

At this point a motion was made to reconsider the vote under Article 11 whereby the Town refused to appropriate money for extension of water pipe. The motion was lost 25 Yeas 59 Noes.

**Article 17      By-Law**

Voted to pass over Article 17 of the Warrant (By-Laws must be amended at Annual Meeting.)

**Article 18      Water Y.M.C.A.**

Voted, to refer Article 18 to the next Annual Town Meeting.

**Article 19      Gloucester St.**

Voted to accept Gloucester Street as laid out by Selectmen.

**Article 20      Elmwood Cemetery**

Voted: - to instruct the Cemetery Commissioners to petition the County Commissioners to take the entire lot of land owned by the Whittier Brothers, to enlarge Elmwood Cemetery.

Adjourned at half past ten to meet next Saturday at this place at half past seven p.m.

A motion was made that a Committee of five citizens, consisting of Edward A. Bower, Alfred Sagar, Albion G. Pierce, John D. Emerson and Frederick A. Russell be a committee to consider the subjects embodied in Article 21 and report thereon at the next Annual Town Meeting. Said Committee to pay all expenses incurred by them without cost to the Town. Albion G. Pierce declined in favor of Edgar Gilbert. The vote was taken by show of hands and was lost – 34 Yeas – 59 Noses.

### Reconsideration

of Art. 16      A motion was made to reconsider the action taken at the last meeting, where by the Town refused to vote to appoint a Committee to employ an engineer to prepare plans for a permanent sewerage system in the Pleasant Valley District. The vote was taken by a show of hands and was carried by a vote of 60 to 22. It was then voted to appoint a committee of three to employ an engineer to prepare plans for a permanent sewerage system in the Pleasant Valley District, to report at the next Annual Town Meeting, and appropriate One Hundred Dollars for that purpose.

### Article 22

#### **Laborer's Day**

A motion to pass over Article 22 of the Warrant was made and was lost. Voted to amend by inserting after the word Commissioners, the words

“and all public works”, and after the word laborers, “residents of Methuen”. The article as amended was then carried, and reads as follows: Voted that the Water Commissioners and all public works be authorized and instructed to pay the laborers residents of Methuen two dollars per day of nine hours, the same to take effect immediately after its passage.

Article 23 **Tree Warden Salary**

A motion to pay the Tree Warden a salary of \$600.<sup>00</sup> per annum was lost, and no other action was taken.

Article 24 **Sewer**

Voted: - to lay three hundred feet of eight inch sewer on East Street and appropriate three hundred dollars for that purpose.

Article 25 **Policemen**

Voted: - that the Chief of Police provide the necessary men to patrol the vicinity between Phippen's turnout and Sargent's Corner as called for in Article 25, and that the pay therefor be taken from the regular appropriation.

Article 26 **Street Light**

Article 26 was referred to the Committee on Street Lighting.

Article 27 **Street Light**

Article 27 was referred to the Committee on Street Lighting.

Article 28 was referred to the Committee on Street Lighting.

Article 30 **Elmwood Cemetery**

Voted to pass over Article 30 of the Warrant. At 9-50p.m. the meeting voted to adjourn to August third at 7-30p.m.

## **Record of Adjourned Town Meeting held August third A.D. 1908**

**The meeting was called to order at half past seven o'clock p.m. by the Moderator, Granville E. Foss.**

### **Article 2 Street Lighting**

The report of the Committee on Street Lighting was called for and a verbal report was made by Edgar Gilbert. He reported in substance, that the Committee favored a new kind of light, known as the Tungsten incandescent light. He explained its working to the meeting at considerable length and at the conclusion of his remarks, moved that the Town adopt a system of tungsten incandescent electric lights. The motion was adopted by a unanimous vote. It was then Voted, without an opposing vote – that the Selectmen be instructed to make a contract with the Lawrence Gas Company to install a system of incandescent tungsten electric lights of 50 watt power – 240 in number, at seventeen dollars per light, per year, the contract to be for a period of five years.

Additional lights to be furnished at the same rate. Contract to include arrangements for “moonlight schedule”.

Voted: - that the Committee on Street Lighting be empowered to arrange the details of installation of the new lights under the contract.

Voted: that the report of the Committee be accepted, also,

Voted by a unanimous vote that the thanks of the Town be tendered to the Committee for the satisfactory manner in which they had performed their work.

Voted: - that Mr. John W. Bridge be added to the Committee.

Voted: - that the Moderator appoint the Committee voted under Article 16 of the Warrant.

The Moderator appointed Joseph S. Howe, Frederick A. Russell and George Bunting as that Committee.

### **Article 20 Cemetery**

A motion was made to reconsider the action taken on Article 20 of the Warrant whereby the Cemetery Commissioners were instructed to petition

the County Commissioners to take land to enlarge Elmwood Cemetery. It was stated that the Commissioners refused to entertain the petition on the ground that the statute required the petition to come from the Selectmen instead of the Cemetery Commissioners. A vote was taken by show of hands and it was voted by a unanimous vote to reconsider. The Town then voted to substitute the Selectmen for the Cemetery Commissioners and the vote now stands as follows: -

Voted: - that the Selectmen be instructed to petition the County Commissioners to take the entire lot of land owned by the Whittier Brothers, to enlarge Elmwood Cemetery. No other business appearing, it was voted to adjourn, sine die.
